Call to Order and Welcome of Guests

Chair Deloach called the meeting to order at 6:04 p.m. She called on Mark Christmas for the invocation.

Approval of Agenda

Chair Deloach presented the agenda and inquired as to whether there were any additions, changes, or deletions. She asked to move the Roman United discussion from number 5 to number 1 on the agenda and to add a sponsorship request from the Clayton County Office of Economic Development to the discussion about Economic Development Week under item 9. 5. **Update from Executive Director**

Director Vincent reported on several projects his office is working on. The administration of the ARPA grants is ongoing, with approximately half of the funding expended to date. He is working with the State on Project Woodpecker, which is an approximately \$14 million retention and expansion project. Project Azalea near the airport is in the beginning stages of phase II (north of Conley Road) and phase III (south of Conley Road); phase I is already underway, with Victory Station already under construction. He is working on the annual audit and also reminded the Board that there will be a job fair on May 19, 2023, at the Riverdale Town Center.

She reported that Toto is still preparing the materials to submit with the bond application, which is expected to be presented for the June meeting.

Director Vincent reported that the Mountain View update had been covered during the Project Azalea discussion in the update from the Executive Director.

9. **Economic Development Week**

Chair Deloach reported that this week is Economic Development Week. Director Vincent attended the first event on Monday at Fort Gillem. Chair Deloach reported that the County's Office of Economic Development had asked the Authority to cover the cost of a barbecue luncheon on Thursday, May 11, 2023, for approximately 150 people, at a cost of \$5,000.00. After a general discussion, the matter failed for lack of a motion.

10. **BOC/DACC Social Event**

Chair Deloach reported that there was a suggestion from Board member Dr. Harrison Braddy to host a dinner with the members of the Clayton County Board of Commissioners. Dr. Braddy reported that the idea is to host a social gathering between members of the Authority and the Board of Commissioners, not to discuss business, but to build unity and lay a foundation for conflict resolution and future business meetings. The goal is to come together with one mind, one strength, no division. Dr. Braddy is communicating with the Commissioners to confirm attendance
