# “Next-Gen Data Engines Arrive in Clayton”

A \$959 M data-center commitment puts Clayton at the heart of digital infrastructure.

The DACC recently green lit a massive investment by a subsidiary of TA Realty; a \$959 million data center development planned along East Tanners Church Road in Clayton County. This positions the county as a major player in metro Atlanta’s booming digital infrastructure market. While details of the tax incentive package remain under wraps, the project underscores DACC’s strategic focus on high capacity infrastructure, global connectivity and job creation in advanced industries.







## TOTO Expands U.S. Operations in Clayton County

*TOTO Opens \$224 Million Manufacturing Facility in Clayton County*

TOTO, the world’s leading plumbing manufacturer, has opened a \$224 million state-of-the-art manufacturing facility in Morrow, Georgia, marking a significant investment in Clayton County’s growing industrial landscape. The new plant expands TOTO’s North American operations by shifting production from Asia to the U.S., strengthening supply chain resilience, sustainability, and local job creation. The Development Authority of Clayton County joined company executives and community leaders for the official ribbon cutting ceremony, celebrating a milestone that reinforces the county’s position as a hub for advanced manufacturing and international investment.

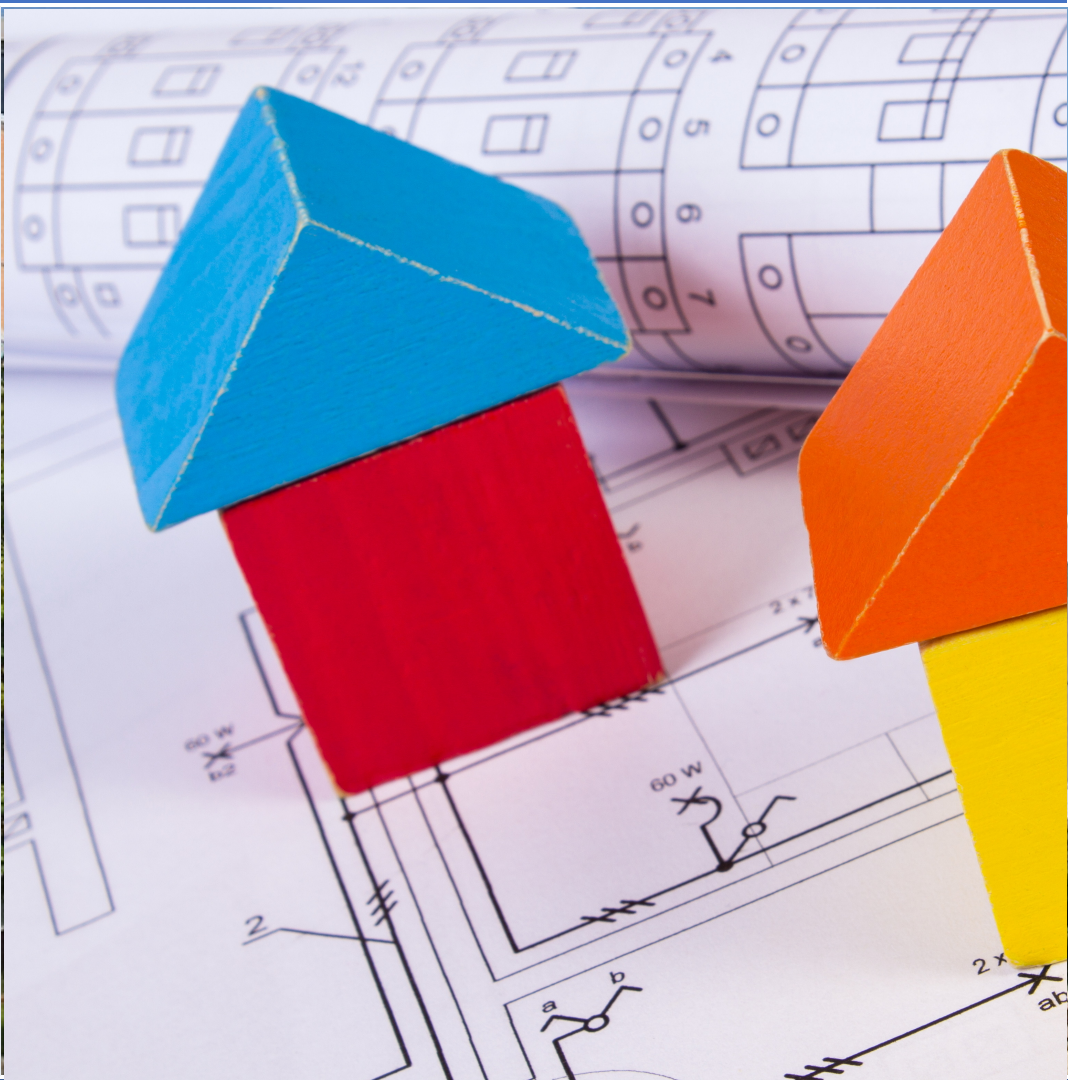

## Fueling the Next Generation of Entrepreneurs

*Investing \$500K in Clayton County's Future*

The Development Authority of Clayton County is launching a \$500,000 initiative to fuel small businesses and empower youth entrepreneurs. In partnership with the Clayton County Public Schools, the program aims to equip youth and local businesses with the tools, mentorship, and support needed to drive economic growth. With a vision to impact 500 businesses, this effort strengthens operations, fosters innovation, and builds a thriving entrepreneurial culture, laying the foundation for a resilient, opportunity rich Clayton County economy.

## Building the Future:

*\$246 Million North Clayton High Project Breaks Ground*

Clayton County Public Schools has begun construction on a new \$246 million North Clayton High School, a bold investment linking education and economic growth. Funded by SPLOST, the project is set to open in July 2027, replacing the county's 60 year old campus with a modern hub for learning, athletics, and community health.

The new facility will feature a nine-hole golf course, indoor soccer and track complex, 5K cross country course, and a public health clinic, amenities that blend academics, wellness, and workforce readiness. Beyond transforming student experiences, the project is expected to create jobs, attract local investment, and showcase Clayton County's commitment to preparing the next generation for success.
